Andrade's neighboring friend, Mark Lamont, ran over and pulled JOHNSON off Christen and a bouncer from the nearby club helped separate DOAK from Andrade. DOAK and JOHNSON then ran from the scene when they were told police were being contacted. DOAK left his wallet behind at the scene and subsequently returned. As a result of the assault, Andrade sustained a cervical strain, head trauma and rib contusion. Further, several of his teeth were knocked loose which required orthodontic repair.

The statement of Maxwell Christen that he was with Andrade when they were approached by DOAK and JOHNSON who called them "faggots" and made other inflammatory statements concerning their sexual orientation. After telling them they didn't want any trouble, DOAK pushed Andrade and then punched him. He was then attacked by JOHNSON who took him to the ground by his neck. Christen stated that Lamont then ran over and pulled JOHNSON off of him. Christen stated his neck and face were sore after the assault and he sustained a bruise to his chin.

The statement of SLCPD Officer Uyema that he responded to the scene and took statements from Andrade, Christen, and Lamont. As he was speaking to them, DOAK and JOHNSON returned to the scene to retrieve DOAK's wallet and Officer Uyema confirmed their identities. DOAK told Officer Uyema that he "was probably involved" in the altercation but did not remember what happened because he had been drinking. JOHNSON said he was not involved in the altercation in any way.
