CHAIR'S REPORT:

Michele Corigliano, 2023 Chair, let the Board know that the 2023 budget was approved.

Michele Corigliano thanked those who attended the Legislative Breakfast this month. There were 9 Legislators along with Health Department staff and Board of Health members who attended.

Michele reminded the Board that the 2023 Legislative Session starts January 17th and encouraged those to attend as their schedule allows. She mentioned the Bill Watch tracking summary located on the Association of Local Health Departments website as a useful tracking tool.

DIRECTOR'S REPORT:

Dorothy Adams, Associate Director, informed the Board that an extension to the emergency declaration regarding COVID-19 was not requested by Dr. Dunn. The declaration official expired on January 3, 2023. Dorothy Adams informed the Board that due to funding received from the Workforce Development Grant, the Health Department was able to recognize 22 of its staff through bonuses. They also awarded a team award recognizing WIC employees for the work they did during the national formula shortage. She stated the Health Department is looking for ways to augment their already robust program that allows peers to recognize each other with the remaining grant funding.
