The meeting was called to order at approximately 7:30 AM Michele Corigliano, Chair of the Salt Lake County Board of Health.

MINUTES:

Michele Corigliano, Chair, asked if there was a motion to approve the minutes from the April 6, 2023, Board of Health meeting. *A motion was made by Dan Eckersley, seconded by Kalina Duncan, to approve the minutes from the April 6, 2023, Board of Health meeting.* The motion passed unanimously, showing that all Board members present voted "Aye."

CHAIR'S REPORT:

Michele Corigliano, Chair, gave a brief update on the UALBOH Symposium that took place at the end of April. She mentioned that there were many attendees from Salt Lake County. She encouraged those who could attend next year to do so. She gave a brief overview of the topics covered.

DIRECTOR'S REPORT:

Dr. Angela Dunn, Director, gave the Director's report.

Dr. Dunn let the Board know that WIC funding for Utah has been decreased due to the last 3-5 years of WIC participation. There is currently an increase in WIC participation. The WIC funding formula is based on population density, number of participants and number of children living in poverty. The funding formula is reviewed annually.

Dr. Dunn reminded the Board that Samsung is no longer funding SLCoHD's e-waste program. There is a team that is looking at potential policies to encourage industry and residents to recycle e-waste responsibly.

Dr. Dunn informed the Board that covid vaccines are set to be commercialized. The SLCoHD Immunizations team is looking at how this will impact covid vaccine services moving forward.

Dr. Dunn commended the SLCoHD investigation team for their work during a recent measles outbreak.

Dr. Dunn let the Board know opportunities will be available for the Board to learn more about the health department by participating in "ride alongs" with health department staff.
