Bills can delete from Utah Code without containing repeal language. Repeal language usually indicates that an entire section of Code is deleted. Often these repealed sections are brief sunset clauses included in previous statutes; thus, repeal language need not imply reducing the body of Utah law.






BILLS THAT CREATE NEW CRIMES




BILLS THAT INCREASE PENALTIES
